

# PRENATAL CARE: REGARDLESS OF IMMIGRATION STATUS

## What is State Husky B- Prenatal Care?

HUSKY B-Prenatal Care provides health care to pregnant non-citizens. The federal Children's Health Insurance Program (CHIP) allows states to include unborn children in their program. This coverage allows for prenatal care and other health care for pregnant non-citizens who do not qualify for Medicaid.

### Who is eligible?

ELIGIBLE INDIVIDUALS MUST BE:

- Pregnant
- A non-citizen or immigrant that does not qualify for Medicaid due to immigration status
- Have a household income under 264% of the Federal Poverty Level (FPL)

\*Please note that unlike in traditional HUSKY B, there is no age limit or age requirement for this program.

Once born, the child will receive HUSKY coverage through the plan HUSKY A- Newborn

### What are the benefits?

FULL RANGE OF HUSKY B BENEFITS INCLUDING:

- pregnancy-related care
- preventive care
- dental and behavioral health
- prenatal doctor visits, prenatal vitamins, ultrasounds, and other tests

### Is labor & delivery included?

Yes

- Labor and delivery will be automatically covered for noncitizens
- Active enrollees on Husky B- Prenatal care will not be required to submit a separate application for labor and delivery coverage

### How much does the coverage cost?

- No monthly premium
- No copayments for pregnancy-related care (prenatal visits or vitamins etc.)
- Copayments or other cost-sharing for services such as specialty and dental care

### Will I receive a card?

Yes

Members will receive a CONNECT card (gray) and Husky Health card (blue and white)

### Which doctors & hospitals participate?

Doctors hospital, and other providers who normally accept Medicaid and CHIP will participate

### What is the income eligibility limit?

### Does this program affect my citizenship application?

No, it will not affect the chance of becoming a Permanent Resident or U.S. citizen.
